### Manager's Update as of 28-Jun-2019

### **A. Material Credit Updates**

#### Overall Portfolio Update

The Weighted Average Rating Factor ("WARF") of the Portfolio as of 28 June 2019 is 681, compared to 685 as of 31 March 2019. The change in WARF is mainly due to principal repayments of various facilities within the Portfolio. As of 28 June 2019, the Issuer is compliant with the Overcollateralization Tests and the Interest Coverage Tests.

### **Project Specific Developments**

In the 31 March 2019 Quarterly Report, we have informed that there was a delay in the receipt by the Issuer of an interest payment of approximately US\$0.5 million for Project I due 7 March 2019, which was deemed to be administrative in nature. This amount has since been received.

### **B. Country and Sector Developments**

There has been no change to the sovereign country risk ratings of the facilities during this quarter. The sovereign rating of Kuwait was reaffirmed during the quarter. In addition, we are not aware of any material adverse sector developments relevant to the Portfolio during this quarter.






