Assessment Announcement: Moody's: No adverse rating impact on notes issued by Bayfront Infrastructure Capital Pte. Ltd. following asset sale

17 Aug 2022

Hong Kong, August 17, 2022 -- Moody's Investors Service announced today that Bayfront Infrastructure Capital Pte. Ltd.'s (Issuer) binding agreements (Asset Transfer Agreements) with certain financial institutions for them to purchase all of the Issuer's portfolio would not, in and of itself and as of this point in time, result in a reduction, placement on review for possible downgrade or withdrawal of Moody's current ratings on the Issuer's Class A notes, Class B notes, and Class C notes (together, the "Notes").

The 25 outstanding assets in the portfolio are sold to certain financial institutions as stipulated in the relevant binding agreements. Part of the sale proceeds have been received by the Issuer and are sufficient to meet the amount required to redeem the Notes at par plus any accrued and unpaid interests.
